

**“TSAWWASSEN MILLS” 12 DAYS OF GIVING CONTEST
(The “Contest”)**

RULES AND REGULATIONS

NO PURCHASE NECESSARY TO ENTER THE CONTEST. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. TO COMPLETE YOUR ENTRY YOU MUST READ AND AGREE TO THE FOLLOWING TERMS. PARTICIPATION IN THIS CONTEST CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT AND ACCEPTANCE OF THESE CONTEST RULES. ALL DOLLAR AMOUNTS ARE IN CANADIAN FUNDS (\$CDN) UNLESS OTHERWISE NOTED. **THE CONTEST IS OPEN TO ALL RESIDENTS OF BRITISH COLUMBIA, CANADA WHO ARE 19 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.**

(1) CONTEST PERIOD (the "Contest Period"):

The contest is held by Ivanhoe Cambridge Inc. (the “**Contest Organizer**”) and will begin **Saturday, December 1st, at 10am (PST)** and will end on **Wednesday, December 12th, 2018 at 9:00pm (PST)** (the "Contest Period").

(2) HOW TO ENTER

No purchase necessary. To enter the Contest each participant must enter by completing an entry form on one (1) of the four (4) iPads at Tsawwassen Mills Shopping Centre. Each participant must fully complete the entry form, which requires the participant to complete: (i) all data fields (e.g. full name, date of birth, phone number, email address); and (ii) all questions/preferences/opt-ins (e.g. would you like to subscribe to the e-newsletter) (individually an “**Entry**” and collectively, the “**Entries**”).

There is a limit of one Entry per person per day during the Contest Period. Each completed Entry must be submitted during the Contest Period.

CONTEST ENTRIES ARE MONITORED AND IF THERE ARE MULTIPLE SUBMISSIONS FROM ONE PARTICIPANT IN A SINGLE DAY, THOSE SUBMISSIONS WILL BE INVALID FOR PURPOSES OF THE CONTEST AND MAY IN THE SOLE AND ABSOLUTE DISCRETION OF THE CONTEST ORGANIZER RESULT IN DISQUALIFICATION FROM THE CONTEST.

ENTRIES GENERATED BY A COMPUTER PROGRAM, ROBOTIC OR OTHER AUTOMATED MEANS WILL BE DISQUALIFIED.

(4) ODDS

(5) WINNER SELECTION:

On December 13th, 2018, twelve (12) Entries will be randomly selected from all eligible entries submitted during the Contest Period to be declared the Holiday Prize Package winners. The Contest Organizer or its designated representative will contact the participants corresponding to the selected Entries by telephone (using the information provided at the time of Entry) (such participant referred to as the “**Potential Winner**”). If the Contest Organizer or its designated representative is unable to contact the Potential Winner by **9:00 AM on January 4, 2019**, such Potential Winner will be disqualified at the Contest Organizer’s sole and absolute discretion and the Potential Winner will forfeit all rights to the Grand Prize. The Contest Organizer may in its sole and absolute discretion hold another random draw to select another eligible Entry from among the remaining eligible Entries, in which event the foregoing provisions herein shall apply to such newly selected Potential Winner.

Before being declared the confirmed Holiday Prize Package winners (the “**Winners**”), the Potential Winners must successfully answer a skill-testing question unaided and unassisted and present government-issued photo identification verifying the residency and age of the Potential Winner and sign a Declaration and Waiver of Responsibility Form.
